Includes (i) 623,834 shares (the "Sponsor Shares") of common stock, par value \$0.0001 per share, of AerSale Corporation (the "Common Stock") held directly by Monocle Partners, LLC ("Sponsor") and indirectly by Richard J. Townsend as a manager of the Sponsor, and (ii) 157,621 shares (together with the Sponsor Shares, the "Securities") of Common Stock held directly by Stone Pier LLC ("Stone Pier") and indirectly by Richard J. Townsend as the managing member of Stone Pier. On September 13, 2023, out of the 1,368,385 shares of Common Stock that it had previously held, the Sponsor transferred 586,930 shares of Common Stock to its other two managers and 157,621 shares of Common Stock to Stone Pier, a member of the Sponsor. Mr. Townsend disclaims beneficial ownership of the Securities except to the extent of his pecuniary interest therein.
